1. that road access is granted via the neighbouring development (Gladman site) through parking spaces 1 and 2. Further access is potentially possible through Bathing Place Lane.

2. existing access to the site be converted to a floodlit path to provide pedestrian access to the town centre.

3. that additional drainage and sewerage works are facilitated to alleviate the risk of flooding on Springfield Oval as they are already over capacity.

4. that a contribution is requested to provide additional health, educational and sporting facilities in the town.
