174 **ELECTION OF TOWN MAYOR FOR 2019/20**

Before the formal business of the meeting began, Area Dean, Rev'd Toby Wright blessed the Town Council for the coming municipal year.

The retiring Mayor, Mrs Churchill, invited nominations for the position of Mayor. Cllr Enright was nominated. There were no other nominations. All members were in favour.

Cllr Enright made a short speech about the year ahead and also thanked the retiring Mayor for her work. He stated that for the forthcoming term of the Council, members did not need to wear a suit jacket or tie for Full Council meetings.

Cllr Enright read out the NOLAN principles and signed a declaration agreeing to abide by them. This was passed around for all other members to sign.

RESOLVED: that Cllr Duncan Enright be elected Town Mayor for the ensuing municipal year.

The Town Clerk advised that the Declaration of Acceptance of Office would be signed following the meeting.

Mrs Churchill left the meeting at this point, along with 1 member of the public.

Councillor Aitman was nominated as Deputy Town Mayor. This was seconded and all were in favour. There were no other nominations.
